DECLARATION OF PATRICK MCNALLY

- I, Patrick McNally, declare under penalty of perjury that these statements are true and correct to the best of my knowledge, information and belief:
- 1. I have been licensed to practice law in the state of Tennessee since 1982, and licensed to practice law in the Commonwealth of Kentucky since 1984. I am admitted to practice in the United States District Courts for the Western, Middle, and Eastern Districts of Tennessee, United States District Courts for the Western and Eastern Districts of Kentucky, in the United States Court of Appeals for the Sixth Circuit, and the Unites States Supreme Court.
- I earned my J.D. from the University of Tennessee in 1982. I earned my B.A. from the Wake Forest University in 1977.
- From 1982 to 1986, I served as a Public Advocate in Hazard, Kentucky. From 1986 to
 I was a Senior Public Defender with the Metropolitan Davidson County Public Defender's
 Office in Nashville, Tennessee.

4. I entered private practice in 1991 with the law firm of Hollins, Wagster, & Yarbrough. My practice includes federal and state criminal defense. I handled a civil rights case through a jury trial in federal district court involving a police canine attack on an arrestee arising out of Clarksville, Tennessee.
